Judge's Contract

Transportation will be provided for the Official from the airport to the hotel/motel and to the show grounds and return. The Official will be brought to the show grounds a reasonable time prior to the start of the first ride or as requested by the Official, if possible.

Cancellation:

Should this show be canceled for any reason after both parties have signed this contract, the Competition agrees to pay the Official as follows:

(1) If the Competition cancels this contract one month or more prior to the competition, the Official shall receive no compensation other than expenses incurred, including airline ticket if purchased by the Official to the extent that it is non-refundable (or, at the Official's election, the Competition will pay a reasonable change of reservation/ticket fee).

(2) If the Competition cancels this contract less than one month prior to the competition, the Official shall receive an amount equal to the compensation stated above for one day of judging, plus expenses incurred, including airline ticket if purchased by the Official to the extent that it is non-refundable (or, at the Official's election, the Competition will pay a reasonable change of reservation/ticket fee).

(3) If the Official must cancel at any time, the Official shall forfeit all compensation from the Competition and shall reimburse the Competition for any airline expenses incurred. The Official shall assist the Competition in finding a suitable substitute acceptable to show management
